OFAC Screening

The USA PATRIOT Act requires you to screen all consumers against the Office of Foreign Assets Control (OFAC) list of terrorists, drug traffickers and money launderers prior to any sale. CoreLogic Credco can screen your customers against the most current OFAC list and deliver results automatically with every credit report.

ID Verification

CoreLogic Credco BuyerID Index provides a first step in our ID verification process. Automatically delivered along with the buyer's credit report, it provides a three-digit numeric score (ranging from 000 to 999) that indicates the level of risk associated with that buyer - the higher the score, the greater the probability of identity risk. This risk-based identity verification score is designed to help you prevent identity theft before it happens.

Credit Score Disclosures

CoreLogic Credco offers the Credit Score Disclosure exception as a compliance solution for the Risk-Based Pricing regulation.
